- 這是由賬戶持有人向南方匯發證券有限公司(“本公司”)提供的自我證明表格，以作自動交換財務賬戶資料用途。南方匯發可把收集所得的資料交給稅務局。稅務局會將資料轉交到另一稅務管轄區的稅務當局。  
This is a self-certification form provided by an account holder to China Southern Securities Limited (“The Company”) for the purpose of automatic exchange of financial account information. The data collected may be transmitted by the company to the Inland Revenue Department for transfer to the tax authority of another jurisdiction.
